# Taxes & Misc

Agency	Assistance
Charitable Donations	<ul style="list-style-type: none"><li>• Up to a \$300 deduction in 2021 for single filers taking a standard deduction. <b>\$600 for joint filers.</b></li><li>• Up to 100% deductibility for those who itemized (excluding donations to foundations and donor advised funds).</li></ul>
Employee Retention Tax Credit	<ul style="list-style-type: none"><li>• <b>Increase from 50% to 70% for qualified wages</b></li><li>• <b>Credit available to new employers not in existence in 2019</b></li><li>• <b>PPP recipients may claim ERTC for wages not paid with PPP funds</b></li><li>• <b>Businesses up to 500 employees are eligible.</b></li><li>• <b>Program sunsets June 30, 2021</b></li></ul>
Educators	<ul style="list-style-type: none"><li>• <b>Out of pocket expenses incurred by educators for PPE and COVID related cleaning materials is deductible.</b></li></ul>
